**DECLARATION OF STEVE  
ZELTZER IN SUPPORT OF  
MEMORANDUM OF POINTS AND  
AUTHORITIES IN SUPPORT OF  
PLAINTIFFS' APPLICATION FOR  
A TEMPORARY RESTRAINING  
ORDER AND/OR ORDER TO  
SHOW CAUSE AND FOR  
PRELIMINARY INJUNCTION**

23 I, Steve Zeltzer, hereby declare:

24 1. I have personal knowledge of the matters stated in this Declaration, and  
25 if called and sworn as a witness in this matter, I could and would competently testify  
26 thereto.

27 2. I am the producer of Workweek Radio on KPOO, an independent,  
28 listener-sponsored, noncommercial radio station. Workweek Radio reports on local  
and national issues concerning working people and the labor movement. I also

1 contribute to the radio show “COVID, Race and Democracy” on the Pacifica Affiliate  
2 Network, a program of the Pacifica Foundation, and produce video documentaries  
3 for the Labor Video Project, an online channel for labor news. As a labor journalist, I  
4 am a member of the Labor Radio Network, a national association for labor  
5 journalists with 70 members.

6 3. I first met Keith H. “Malik” Washington in December 2020 through  
7 Mary Ratcliff, the previous editor of the San Francisco Bay View National Black  
8 Newspaper. Mary suggested that Malik give me a call because of a story involving  
9 Malika Alim, a whistleblower in the San Francisco Health Service system.

10 4. Malik had received a letter documenting incidents of racism in the San  
11 Francisco Health Service system. I was in contact with other whistleblowers in the  
12 system, and we worked together on stories concerning the San Francisco Health  
13 Service.

14 5. The SF Bay View published a story on Malika Alim, “Racist Practices at  
15 the SF Health Service System Will No Longer Be Tolerated: Remove Mitchell Griggs  
16 Now!” on December 22, 2020.<sup>1</sup>

17 6. Over the next month from December 2020 to January 2021, Malik  
18 appeared on my radio show, Workweek Radio, four times to discuss racism against  
19 black employees of the City of San Francisco.

20 7. On January 11, Malik, acting for the SF Bay View, and Workweek Radio  
21 organized a press conference and rally in front of the San Francisco Health Service  
22 System building at 1145 Market Street in San Francisco. The rally was scheduled for  
23 12 noon – 1 p.m.

24 8. Mary Ratcliff of the San Francisco Bay View requested permission from  
25 the Taylor Street Facility for Malik to attend the rally and press conference. I learnt  
26 from the SF Bay View that the permission was granted.

1           9.       On the day of the rally, I learnt about the COVID outbreak at the Taylor  
2 Street Facility and the retaliation against Malik. Malik was confined to his room at  
3 the Taylor Street Facility, and was unable to attend the rally.

4           10.       Following the rally, I learnt from the SF Bay View that Malik had been  
5 disciplined for exposing the COVID outbreak at the Taylor Street Facility, that his  
6 cell phone had been confiscated, and that a ban had been imposed on his ability to  
7 speak with members of the press.

8           11.       Since the ban was imposed, I have not attempted to contact Malik  
9 because of the ban, whether on the phone or any other medium, because of my fear  
10 that he will be retaliated against.

11           12.       I do not know whether any communication between me and Malik, or  
12 any collaboration with him on reporting, will subject him to retaliation from the  
13 Taylor Street Center.

14           13.       Malik has not appeared on Workweek Radio since his discipline was  
15 imposed on January 10, 2021.

16           14.       I have not collaborated with Malik on any reporting since his discipline  
17 was imposed on January 10, 2021.

1 I declare under penalty of perjury that the foregoing is true and correct, except  
2 as to those matters stated on information and belief, and as to those matters I believe
